Upon receipt of the completed application and payment for extended warranty coverage, Blue Sky Energy will return a warranty purchase invoice to the indicated address showing the purchase of extended warranty coverage. This purchase invoice indicates that the extended warranty has become effective. Incomplete extended warranty applications or those post marked beyond the 90 application period will not be accepted or processed. **It is the responsibility of the purchaser to retain these documents and make them available to obtain extended warranty coverage.**

## **OPTIONAL FIVE YEAR LIMITED WARRANTY**

Blue Sky Energy (hereinafter BSE), hereby warrants to the original consumer purchaser, that the product or any part thereof will be free from defects due to defective workmanship or materials for a period of five (5) years from the date of purchase subject to the conditions set fourth below. If within the coverage of this optional limited warranty, BSE will repair or replace the product at BSE's discretion. The original consumer purchaser is responsible for transportation costs and insurance to return the product to BSE. BSE will provide ground transportation and insurance to return the product within the continental US.

1. The extended limited warranty is provided at additional cost and is not included in the standard cost of the product.
2. This limited warranty is extended to the original consumer purchaser of the product only, and is not extended to any other party.
3. The limited warranty period commences on the date the product is sold to original consumer purchaser.
4. This limited warranty does not apply to any product or part thereof damaged by; a) alteration, disassembly or application of a foreign substance, b) repair or service not rendered by a BSE authorized repair facility, c) accident or abuse, d) corrosion, e) lightning or other act of God, or f) operation or installation contrary to instructions pertaining to the product.
5. BSE's liability for any defective product or any part thereof shall be limited to the repair or replacement of the product, at BSE's discretion. BSE will not be liable for any loss or damage to person or property, or any other damages, whether incidental, consequential or otherwise, caused by any defect in the product or any part thereof. Some states do not allow exclusions or limitations of incidental or consequential damages, so the above limitation may not apply to you.
6. Any implied warranty for merchantability or fitness for a particular purpose is limited in duration to the length of this warranty. Some states do not allow exclusions or limitations on how long an implied warranty lasts, so the above limitation may not apply to you.
7. This warranty gives you specific legal rights, and you may also have other rights which vary from state to state.
8. To obtain extended warranty repairs, contact BSE at 800-493-7877 or 760-597-1642 to obtain a Returned Goods Authorization (RGA) number. Mark the outside of the package with the RGA number and return the product, postage prepaid and insured to the address below. **A copy of the original purchase receipt, extended warranty coverage form, and extended warranty invoice must accompany the product to obtain extended warranty repairs.**
